

'Friends of TDA' Draw Rules

updated June 18, 2019

Eligibility

Winner must be 18 years or older. Entry must be based on a referral from one of TDA Global Cycling's former participants (the "Referrer"). The referral can be a friend or family member (the "Friend") but the entry must be someone who has never participated in a cycling tour run by TDA Global Cycling and cannot have been referred in previous 'Friends of TDA' draws.

Newsletter

Entry into the draw also subscribes the Friend to TDA Global Cycling's monthly email newsletter.

The Draw

No prize is awarded if less than 50 total entries in the draw. All entries must be received by December 11, 2019. Only one entry per person. The prize draw will be held on December 13, 2019. Prize winner will be announced in the next quarterly alumni newsletter (TDA Insider News) and all prize entrants will be informed by email. Prize must be claimed by December 20, 2019.

There will be one draw to choose the Friend (and their Referrer) who wins the free section (the "Main Prize"), and 10 additional draws to choose the 10 Referrers who win the t-shirts (the "Consolation Prize").

Prizes

The Friend who wins the draw can choose one section on any of the cycling tours listed on TDA Global Cycling's website found at: <http://tdaglobalcycling.com/tour-finder> with a value of US \$5000 or less. Their registration fee (US \$150) and their entry fee (valued at up to US \$5000) for the chosen section are waived.

The Referrer who wins the draw will also be given the opportunity to join for the same section chosen by the Friend. Their registration fee (US \$150) and their entry fee (valued at up to US \$5,000) for the section are waived for the referrer as well.

The Friend and the Referrer who win the draw can also use the prize as credit towards a section with a value of more than US \$5000, multiple sections or a full tour. For full tours, the section credit will be based on the prorated amount of the full tour price. The credit amount will never exceed US \$5000.

Consolation Prize of 10 TDA t-shirts will also be awarded to 10 Referrers and chosen through a random draw. Consolation Prize winners can choose any one t-shirt from the TDA T-Shirt Shop found at: <https://shop.tdaglobalcycling.com/>

None of the prizes have any cash value, and the Main Prize must be used for a section on one of our tours within 3 years of the date of the prize draw. The winner must answer correctly within a 5-minute time period a mathematical skill-testing question without the benefit of any calculating devices in order for the prize to be awarded.

TDA Global Cycling is not responsible for any loss whatsoever that may arise from use of the prize. The Main Prize does not include flight or other costs associated with joining the cycle tour.
